Jurisdiction - General Information

Brazil has been a Contracting Party to the Paris Convention for the Protection of Industrial Property since July 7, 1884. It has also been a Contracting Party to the Patent Cooperation Treaty (PCT) since April 9, 1978, and is also a party to the Patent Law Treaty (PLT).

Brazil is also part of the regional IP information platform [LATIPAT](#) and a member of the "SISTEMA DE COOPERACIÓN SOBRE ASPECTOS DE INFORMACIÓN OPERACIONAL Y DE PROPIEDAD INDUSTRIAL" ([PROSUR](#)).

Online Patent Register and Online Gazette

Brazil has an [Online Register](#) and an [Online Gazette](#).

Features and search functionalities

The Online Register has a **Portuguese interface**.

Through the Online Register you can retrieve information on PCT **National Phase Entry**, **Fee Payment**, **Legal Status**, and access the **Dossier/File Wrapper Information** and the **Full Publications**.

The Online Register can also be searched by **PCT Application/Publication Number**, by **Applicant/Inventor Name**, and by **Priority Data**.

The Online Gazette ("Revista da Propriedade Industrial") is published weekly in Portuguese. It is searchable by number and downloadable in PDF or text format. The current coverage is from 1992 to present.

[LATIPAT](#) provides some bibliographic data and information about the **Legal Status** of Latin American patents. For more information about LATIPAT, consult the [detailed jurisdiction file](#).

PROSUR offers a search engine for patents at this [link](#) which, however, does not appear to be operational at the moment.

Additional Information

Particularities of patent protection in Brazil

Article 40 of the Brazilian patent law 9,279/96 provides a term of validity of 20 years from filing but also a minimum period of protection of 10 years from grant.

Search tips

The search interface of the Online Register can be accessed without registration by clicking on the yellow highlighted word "Continuar...", then selecting " Patente", and finally "Pesquisa Avancada" to access more search fields.

To search by **PCT Application/Publication Number**, enter e.g., US2011035270 as "Numero do Deposito PCT".

To access information about the PCT **National Phase Entry**, enter e.g., "BR 11 2014 028847 0" for "No do Pedido" (Application number), or " US2011035270" for "Numero do Deposito PCT", see "(85) Início da Fase Nacional".

Fee Payment information can be retrieved in the section "Petições". Explanation codes are available under "Serviço".

Full Publications are available by selecting "Documentos Publicados" on the bottom of the bibliographic record.

Legal Status Events are reported as codes, e.g. for PI 9909239-5, "16.1" in column "Despacho" indicates the grant and "24.8" the lapse of the patent.

To access the **Dossier/File Wrapper Information**, go to this [link](#) and input the gazette (revista) number or the particular patent application (pedido) number in the format, e.g. "102012000753" for the application number "BR102012000753-3".

On the page of the **Online Gazette**, only the last few numbers are displayed, but searching in the archive 1992-present is possible by clicking on "BUSCAR PATENTES" and then by inserting a number or a range of dates.
