PATENT OFFICE OF THE COOPERATION COUNCIL FOR THE ARAB STATES OF THE GULF (GCC) - GC

Jurisdiction - General Information

The Patent Office of the Cooperation Council for the Arab States of the Gulf (Gulf Cooperation Council or GCC) is a regional office for the Gulf Cooperation Council, which comprises the States United Arab Emirates, Kingdom of Bahrain, Kingdom of Saudi Arabia, Sultanate of Oman, State of Qatar, and State of Kuwait. Certificates of patents granted by the GCC Patent Office secure legal protection of the inventor's rights in all GCC Member States. A patent is validated in the Member States as of the date of grant in the GCC.

The GCC Patent Regulation and the Statute of the GCC Patent Office were approved by the Supreme Council during the 13th summit meeting of the heads of Member States, which was held in Abu Dhabi on September 21 to 22, 1992. As of October 3, 1998, the GCC Patent Office started receiving applications.

The Gulf Cooperation Council is neither a member of the Patent Cooperation Treaty (PCT) nor of the Paris Convention for the Protection of Industrial Property.

Online Patent Register and Online Gazette

The Gulf Cooperation Council has an Online Register and an Online Gazette.

Features and search functionalities

The online patent register includes only granted patents and has an **Arabic, English, French and Japanese interface**.

Through the patent register you can retrieve basic information on **Legal Status**, which can be deducted from a code.

The patent register can also be searched by **Applicant/Inventor Name**, by **Priority Data** (by priority date only).

There is also a previous release of the patent database still working at this <u>link</u>, providing information about the **Legal Status**.

On the homepage under the Menu "Patent Gazette" it is possible to access lists of patents and applications granted, fallen or rejected and to the archived releases.

The online gazette is available in English. It's coverage is from 2001 (issue no.1) to present, even if no.1-15 are temporarily not available. Most documents are available in HTML and/or PDF format.

Through the online gazette it is possible to access the **Full Publications**.

Additional Information

Particularities of patent protection given by the Gulf Cooperation Council

Protection through **Patent Term Extension** is not available, but referral is made to each country's national law.

According to the decision held by the 41st GCC Supreme Council meeting to amend the existing GCC Patent Law, no new filings were accepted by the GCC Patent Office for GCC patent applications after January, 6, 2021. Patents filed before this date and granted are valid in the territory of all the member countries.

Then, the IP Offices of Bahrain and Kuwait (since January 1, 2023) and Qatar (since July 1, 2023), have resumed the possibility to use the GCC Patent Office as IP authority, however, the applications filed after the resuming date have a validity limited to the national territory of the filing country.

Search tips

An example of data reported as **Legal Status** is "Expired" for patent numbers 2148.
